1. Overview

The purpose of this form

- 1.1 You should complete this form if you are applying for a licence to provide a small-scale radio multiplex service (a 'small-scale radio multiplex licence'). A small-scale radio multiplex service is the means by which DAB digital radio stations ('digital sound programme services') are broadcast, and can transmit around ten stereo digital sound programme services (or a significantly higher number if the DAB+ standard is utilised). The application form is divided into two parts – **Part A** (which we will publish on our website) and **Part B** (which will be kept confidential). This document constitutes Part A; [Part B of the application form](#) is available separately.
- 1.2 Small-scale radio multiplex licences are awarded by Ofcom in a competitive process. Applications are judged against specified criteria, and Ofcom awards the licence to the applicant which it considers best meets the criteria.

- 1.3 There are detailed instructions on how to complete this form, and information on the next steps in the application process, in our [guidance notes](#) for licence applicants and licensees. Please read this guidance and the frequently asked questions carefully before completing this form.



East Devon is a rural polygon of 1,449 square kilometres, and a 2011 population of 136,187 adults, given a population density of just 94 people per square kilometre – or about one per every football-pitch area, as the Office for National Statistics illustrates, below. A polygon without a city, East Devon's settlements are sparsely located and modest in size. Only two, Honiton and Sidmouth, have more than 7,500 residents.





This presents significant hurdles in building a small-scale DAB transmitter network that will cover a significant area satisfactorily and which will be financially sustainable. Total coverage will require a high number of transmitters, leading to both high capital and operational costs, and consequently making carriage fees unattractive to commercial broadcasters compared to multiplexes elsewhere that reach large populations in relatively compact areas. Furthermore, until our participant Sid Valley Radio obtained its C-DSP licence in July, the polygon contained no existing Ofcom-licensed community radio stations at all. As demand from broadcasters on this polygon is, in our opinion, likely to be small, we have built our transmission proposals on the following principles:

- Providing coverage for the two largest towns, Sidmouth and Honiton
- Covering a meaningful population within the polygon with a maximum of three transmitters to ensure a sustainable, long-term financial model
- Avoiding overlapping, wasteful coverage with the Exeter multiplex already served by a transmission site at Cranbrook, a fast-growing new town in the East Devon polygon.
- As both Sidmouth and Honiton look towards Exeter for work, leisure, cultural and much tertiary education, providing good coverage on roads connecting these settlements with the neighbouring Exeter multiplex.
- Providing continuous outdoor coverage within the polygon as far as practicable.
- Minimising overspill into the proposed Exmouth/Dawlish polygon, to preserve the integrity of Ofcom's published plans.
- Making the service affordable to community services, small commercial stations and new entrants

At 13.6 per cent, population growth of East Devon between the 2011 and 2021 Censuses is one of the largest in the UK and more than twice the national average, moving it up 19 places in local authority sizes (see table, below). However, much of East Devon's growth is to the west of the district, around Cranbrook.

ExeDab's existing transmitter site in the East Devon polygon at Cranbrook Education campus serves this town, which is set to have around 20,000 residents by 2030. Land for a second new town has also been identified to the south west of Cranbrook, which will also be covered by the existing Exeter multiplex. As growth is in an area already covered by ExeDab – which overlaps with the East Devon polygon - we believe listeners are best served by the East Devon multiplex operator concentrating resources in the two largest existing settlements in the polygon.

Our chosen locations therefore provide coverage in a south-west to north-east plane across the polygon that are contiguous with the Exeter multiplex, whilst minimising overlap. East Devon District Council's 2022 strategy document *"The role and future of settlements"* outlines how Sidmouth and Honiton have high levels of commuting into Exeter, with a total net outflow from East Devon to Exeter of 11,420 residents....[and] one in five residents of Honiton work in Exeter, far higher than other places outside East Devon." Serving Honiton, therefore, should be an essential requisite of any rational and sustainable plan for this multiplex.

Should ExeDab be awarded this licence, stations choosing to broadcast across both Exeter and East Devon will be able to enjoy affordable seamless transmission between the networks, with listeners benefitting from continuous coverage as they commute. In this area, according to council data, 54 per cent of people travel by car, and 11 per cent by public transport regularly. ExeDab's client stations can be with them on their journeys.

On the downside, and with regret, at this stage our transmission plan leaves the many disperse towns and villages of this very rural polygon unserved, but we believe this to be a price that must be paid in building a sustainable network. We have identified other sites that will cover some settlements, and connecting hinterland, but will not be promising to contract with landlords or build other parts of the network within 18 months of any licence award.

Finally, to avoid compromising the integrity of the proposed Exmouth/Dawlish polygon, we have avoided transmitter locations to the western fringe of the polygon, as we deemed overspill into the Exmouth/Dawlish area could have been considerable and could prove troubling to future applicants for that polygon.

Small-scale radio multiplex licence: Application form (Part A)

A full coverage prediction map for the whole of the transmitter network at the 63 dB μ V/m field strength is shown below. Additionally, Appendix G shows the 54 dB μ V/m and 38dB μ V/m contours. The ward-level population tables (2011 Census) indicate that at 63 dB μ V/m field strength;

- the number of people falling outside the polygon does not exceed 30 per cent of the total population within the advertised licence area; and
- the proposed coverage does not overlap more than 40 per cent of the population within the relevant local radio multiplex service's licensed area.

The transmitter network has been designed to minimise any significant interference above 38 dB μ V/m to other proposed small-scale DAB licence areas.

Financial and business plan

- 3.17 Please provide a high-level estimate of the costs you believe will be required to establish the multiplex service.

A detailed financial forecast in Appendix A sets out establishment costs of £45,000, annual income & expenditure with 36-month cash flow and profit & loss forecast. The financial structure ensures we are not over-capitalised and that the amount invested in the multiplex is not significantly higher than the real value of our assets; that earnings represent a fair return on capital employed and avoids a situation where capital is either idle or invested in assets that are not fully utilised.

ExeDab has already launched a three-transmitter SFN for the Exeter multiplex, while our participants, Exe Communicate and Phonic FM, are also partners in the Plymouth multiplex, PlymDab, a two-site SFN. We are therefore well-aware of, and experienced in, the issues and risks in operating multi-site solutions, particularly in rural areas in which the number of services joining the network may be limited.

As an existing SsDab multiplex licensee, we also have cash in hand from existing operations, and our business plan is predicated on the East Devon multiplex benefiting from the economies of scale of holding two contiguous licences. This is possible as the combined area is projected to overlap with the Arqiva/Now Digital local DAB network by around 24 per cent, well within the 40 per cent allowed under the guidelines.

Capital Investment – £45,000

The main capital investment is the multiplexing & transmission system. Our technology partner Viamux will provide the small-scale DAB solution as well as professional services (project management, site surveys, network design and build, software configuration, installation, training and ongoing support).

Operating Costs – £12,000 per annum

Administration

Managing relationships with landlords, technology providers and prospective and actual radio service clients is time-intensive, and we will be able to share resources and expertise of the Radio Exe team to which two other existing multiplexes, TorDab and PlyDab, in addition to ExeDab, outsource day-to-day management of their small-scale DAB operations.

The usual administration costs associated with operating a company of this size are included (insurance, legal and accountancy services – once again shared with the Exeter licence area) as is the annual Ofcom licence fee (which isn't). We will have proportionately lower insurance and IT expenditure, and a single set of management and statutory accounts, with costs already covered by ExeDab's existing fees.

Transmission

The ongoing costs associated with transmission (site rental, electrical power consumption, internet provision) are the single largest recurring operating expenditure. For this reason, we have carefully selected sites for which we have been able to negotiate negligible rents, meaning transmission costs remain low. This is critical for ensuring long-term sustainability in a rural polygon such as East Devon.

Technical Support & Maintenance

Ongoing technical support for maintaining the multiplex and transmission equipment will be provided by Viamux, by way of an annual support & maintenance contract.

Small-Scale DAB Management Software

We will extend our Exeter multiplex subscription to Optimux to cover the East Devon polygon. This cloud-based control panel simplifies management and monitoring of a small-scale DAB network. For a modest monthly fee, Optimux allows us to implement cloud encoding - making it quick, easy and cheap to add new services to the multiplex. It also provides us with full invoicing and direct debit collection to streamline payments of carriage fees. Optimux also monitors the multiplex and will alert us to any issues.

Funding

Capex is funded through shareholders' loans. Operational expenditure will be sustained by providing existing community and commercial broadcasters, as well as new entrants, with a reliable digital broadcast platform on affordable and flexible terms.

General Management

Day-to-day running of the multiplex operation - managing commercial, financial and operational matters – is outsourced to Radio Exe, which has the expertise, team and resources to support the multiplex, lowering operational costs to ExeDab. Technology support is outsourced to Viamux.

Tasks for ExeDab's internal management include, but are not limited to:

- Recruiting new services
- Relationship management
- Issuing carriage agreements
- Invoice management
- Payment collection
- Working with programme services to ensure DSPS and regulatory licence compliance.
- Monitoring and Ofcom reporting
- Promoting the multiplex and the benefits for service providers and listeners

ExeDab will also be responsible for IT, administration, legal, customer service and technical support.

Team

The participants share a track record of successfully establishing and operating broadcasting operations, including the Exeter multiplex, which launched in 2022. This was in challenging circumstances through the covid period and the subsequent economic turbulence, which included a dramatic rise in energy costs and therefore operational costs for multiplexes.

At the time of writing, ExeDab carries 10 stations. Members of the team also launched the Plymouth multiplex, and consulted on the launch of the Torbay multiplex. All three multiplexes benefit from a shared technology partner in Viamux, and outsourcing of day-to-day management and operations to Radio Exe.

The key people behind ExeDab are as follows:

Dr David Treharne, ExeDab's chair, was instrumental in launching and then operating Phonic FM, Exeter's community radio station, which he now chairs. He presents a jazz show on the station, having hosted similar shows on Exeter's former commercial stations DevonAir and Gemini, as well as Jazz FM. David served as chair of Exeter City Football Club for three years and amongst his academic publications are two volumes on the club specifically and community ownership of football clubs in general. With important chairmanships in Exeter over many years, David has extensive contacts across both city and county.

Paul Nero, managing director of Radio Exe, will have overall responsibility for launching and managing the new service for East Devon, the district where he lives. Since ExeDab launched, Paul has brought four new digital radio stations to air, including an all-speech station, Devoncast Radio, a unique service featuring sport, local politics, and general interest programming, with regular news for Devon from Radio Exe. The forthcoming 10TenDevon is a rolling 10-minute daily news service. Additionally, he has editorial responsibility for the BBC's local democracy reporting service in Devon, for which Radio Exe holds the BBC contract and employs three journalists. No other mainland commercial radio station operates such a prestigious contract to provide public service content to other local media partners, including community radio stations in Devon and the BBC itself.

With a broad media background including at the BBC, Financial Times and in ITV, Paul is now a director of Exeter Chamber of Commerce, which is in the process of merging with Devon and Plymouth Chamber, to provide a powerful voice for businesses across the county and he is on the board of the new Devon Chamber. Consequently he is well-connected with businesses, local authorities and audiences. Paul serves on the advisory panel of commercial radio industry body RadioCentre and is chair of the Devon and Cornwall branch of the Radio Academy. The author of five books, he is a member of the British Academy of Film and Television Arts (Bafta) and holds a first degree from the University of Exeter and an MBA from Bristol Business School.

Ashley Jeary is Radio Exe's programme manager and twice winner of a Radio Academy's 30-under-30 award. A director of ExeDab, he began his broadcasting career at Heart in Exeter. In addition to his management responsibilities at Radio Exe, he presents the station's drivetime show and is responsible for developing new broadcasting talent. Ashley has a deep understanding of the broadcast market in Devon, compliance and technology issues, and is a director of two other small-scale DAB multiplexes, in addition to ExeDab.


Brad Hardware of Radio Exe is responsible for the day-to-day running of ExeDab's Exeter multiplex, as well as the Plymouth and Torbay multiplexes. Brad manages client relationships, including contracts; interactions with landlords of transmitter locations; and the relationship with our technology providers Viamux and Optimux. As a broadcast journalist, Brad is also station manager for Devoncast Radio, the speech station from Radio Exe which he has developed from nascent idea to on-air station on three digital multiplexes. Brad lives in East Devon.

Technical Partners

The ExeDab team is supported by [Viamux](#) and [Optimux](#) – who are already our technology partners in the neighbouring Exeter polygon. Viamux services include multiplex network design & build, installation, support and maintenance.

ExeDab uses Optimux, the market-leading small-scale platform developed specifically to simplify day-to-day management of small-scale DAB multiplexes. It employs an easy-to-use dashboard for managing, monitoring and reporting on all aspects of their multiplex as well as providing invoicing and direct debit collection to simplify the payment of carriage fees. Every aspect of the day-to-day management of a small-scale multiplex has been incorporated into Optimux.



Small-scale radio multiplex licence: Application form (Part A)

Our aim is to launch the multiplex within 12 months of the licence award subject to Ofcom approval of our final technical plan.

Funding is already in place and heads-of-terms are broadly sufficient to meet the operating costs of the multiplex. We are continuing to actively pursue all expressions of interest and are confident the East Devon service can launch with a strong line-up of services, including meaningful speech and content for local audiences.

Following the 'Guide to Launching' flowchart and the procedures set out in Ofcom's Technical Policy Guidance we aim to accelerate the implementation timetable by focusing on stages A to E.



Stages:

A: In response to any technical mitigations in the award letter, we aim to finalise our site agreements and technical plan and submit to Ofcom within six weeks.

B: On receipt of the hole punching document we will liaise with the national and local multiplex operators immediately. Responses received will be sent to Ofcom.

C: Once the technical plan is signed off by Ofcom the equipment will be ordered and specifications shared with Ofcom. Installation date is scheduled and Ofcom is notified with twenty days' notice.

D: Equipment is installed and commissioned.

As a leading small-scale DAB provider, Viamux will manage the implementation of the project. Availability of all equipment, software and professional services to meet our timescales are already confirmed.

We will be responsible for finalising site agreements and arranging broadband connectivity. A project GANTT chart (Appendix E) details the tasks, activities and timescales under which the implementation will be governed to achieve our target launch date.

Sid Valley Radio is a participant in ExeDab. It has operated as an online station for many years and would have liked to have extended into broadcast radio earlier, had an appropriate community licence been advertised. It submitted its C-DSP application to Ofcom in May and its licence was awarded in July. The number is CDP105370BA/1.

Based in Sidmouth, the largest settlement in the polygon, Sid Valley Radio broadcasts from the town's main community and health hub, the Stowford Centre, and is closely involved in the centre's management. ExeDab has the centre's agreement that it can be used as a transmitter site, should future enhancement of the service be required.

Broadcasting online for seven years, the station is a not-for-profit organisation run by a team of around 25 volunteers from all walks of life and backgrounds. Largely music-based, it runs more speech programming in the afternoons, and specialist music in the evenings. A not-for-profit organisation, all members of the station are local to East Devon, and it has a successful work experience programme with local schools. A number of students have continued to volunteer with the station following their placement.

Following Ofcom's advertisement of the licence area in April, Sid Valley Radio became a shareholder in ExeDab, with voting rights proportionate to its stake. Whilst this is relatively modest, it means Sid Valley Radio, as with all ExeDab participants, has skin in the game, has contributed its proportion of ExeDab's costs in cash, and is determined to make a success of small-scale digital radio in East Devon.

The addition of Sid Valley Radio to our group brings the number of community radio stations in ExeDab to three, although to comply with the regulations, only Sid Valley Radio will operate as a C-DSP licensee. Community radio stations own 28 per cent of ExeDab.

This was picked up by local and industry press, further directing people to the ExeDab website. Social media coverage also resulted from this press announcement.

A Sidmouth community radio station has joined a consortium planning to apply to run a new digital radio network for East Devon.

Sid Valley Radio is becoming part of ExeDab which runs the existing Exeter digital service, and which includes Devon's Radio Exe, Phonic FM and Riviera FM.

Outreach: Our participants are well-connected in the media sector in Devon and identified potential services that may be interested in carriage. We made calls and sent emails to invite them to join our line-up.

Approaching a wide range of prospective service providers:

We proactively contacted known existing service providers in the south west, including online stations that may wish to make the switch to DAB in East Devon and the surrounding area. Commercial, community, hospital and student radio stations were all approached.

We outlined our draft transmission plans, as far as practicable whilst negotiations were ongoing with landowners, as well as headline terms of agreement and indicative carriage fees.

From our experience in round one of multiplexes, for which ExeDab was originally incorporated, we are aware that expressions of interest do not necessarily turn into firm commitments to broadcast. The East Devon polygon covers a similar number of residents to the Exeter multiplex, but because of its very rural nature and the very low number of existing stations in the area, we are proceeding with extreme caution to ensure that our financial plan is sustainable should expressions of interest not proceed to final contracts. We expect the number of services to be modest and have budgeted accordingly.

Acting in a manner calculated to ensure fair and effective competition

ExeDab has always acted in a manner that promotes fair and effective competition. Our negotiations with potential service providers are, and will continue to be, demonstrably fair and non-discriminatory. Our reserved capacity policy is published on our website.

We will continue to seek additional service providers and will be delighted to welcome any organisations that have hitherto given exclusive support to any rival group that may emerge. In the interest of fair and open competition, we have not asked any potential service provider for exclusivity in the application process.

Following the launch of the multiplex, we will continue to operate a transparent rate card policy, published on our website. ExeDAB's pricing strategy is pitched to ensure sustainability in a rural polygon requiring multiple transmission sites. Moreover, the structure of our rate-card reflects our core aim of supporting and encouraging community broadcasting and new small-scale commercial services with numerous options of contract terms so stations can opt for the one that suits them best.

We offer broadcasters the flexibility of having their service encoded at source or via our cloud encoders, making it very flexible.
